A. <u>St. Agatha Sewer Status:</u> Discussion to inform new select people of account status and mediation process.

- A. <u>Town Manager Duties</u>: A list of the Town Manager's duties was given to the BOS.
- B. <u>Board of Select People Duties:</u> A list of the BOS' duties was given to the BOS. Discussion of expectations of the BOS by the Town Manager and issues he has had in the past with time management because of BOS visits. This should be kept to a minimum due to the administration's workload.

- E. <u>Election of Valley Recycling Facility, Inc. Board Member</u>: Ryan's title is as Administration. This Board meets every 3rd Wednesday of each month at 9:00 am. Motion made by Jamie Voisine to elect John Ezzy and Yvon Dube. All in favor. Motion Carried.
- F. <u>BYOB Permit:</u> Community Center leased out for an upcoming event. BOS signed the permit application.
- G. <u>Tax Abatement:</u> It was brought to the Town Clerk's attention that a resident had applied for the Veteran's Exemption on 4/1/2014. He was told that he was too late for the 2014 taxes at the time but that the exemption would be effective for 2015 taxes. He received the tax bill in July which didn't include the exemption and came into the office to pay his bill. The past town clerk calculated the difference due and collected. She informed him that the difference would be abated. John Ezzy made a motion to abate the full amount of \$168.82 plus any fees and interest; seconded by Yvon Dube. All in favor. Motion Carried.
- H. <u>Road Committee:</u> This committee will be responsible to implement the plans, contract, financing and public hearing. The seven members nominated for the committee are:
