TOWN MEETING MINUTES FOR MARCH 21, 2017

TO: Eric I. Blanchette, a resident of the Town of Frenchville in the Aroostook County, State of Maine.

Greeting:

In the name of the State of Maine, you are hereby required to notify and warn the voters of the Town of Frenchville in said county and state, qualified by law to vote in town affairs, to meet at the Frenchville Community Center in said town on Tuesday, the 21st day of March, 2017 A.D., at ten o'clock in the forenoon, then and there to act on articles numbered 1 and 2 as set out below; the polling hours therefore to be from ten o'clock in the forenoon until six o'clock in the afternoon.

And, to notify and warn said inhabitants to meet at the **Frenchville Community Center** in said Town on **Tuesday, the 21**st **day of March, 2017 A.D.**, at **seven o'clock in the afternoon**, then and there to act on articles numbered 3 thru all of said articles being set out below, to wit:

Meeting called to order by Town Clerk, Danna M. Ayotte on March 21, 2017 at 10:00 am.

ART. 1. To choose a moderator to preside at said meeting.

Motion by John Ezzy to nominate Aurel Lavoie as Moderator; seconded by Ryan E. Pelletier.

All in favor. Motion carried.

ART. 2. To elect all necessary Town officers as are required to be elected by secret ballot. (M.R.S.A., Title 30A, 2528)

Town meeting called to order by Town Clerk, Danna M. Ayotte at 7:00 pm. Clerk welcomed town people and went over a few housekeeping items:

- If registered, must have a pink card.
- Must use pink card to vote or speak. Hand votes will not be counted. Only pink cards.
- Questions must be based on warrant. No other topics allowed.

Clerk invited Deputy Moderator, Kevin Lavoie to begin meeting.

Section 2442.

It is dangerous to be driving and incurring large expenses in repairs. Concerns about having two trucks only one year apart because they will both be due to change at the same time. Town Manager stated that he plans on gathering the Planning Committee in the near future to put a strategic plan in place for these situations. Eric explained his financial plan which will allow the town to purchase the truck this year and use the Equipment Revenue funds to pay the first payment and delay putting the payment on the warrant until 2019.
